WHEREAS, SNGRDC previously conducted extensive community engagement on lithium storage technology with the Oneida Energy Battery Storage project;

WHEREAS, Six Nations of the Grand River Elected Council (SNGREC) has entered into a Management Agreement with SNGRDC dated March 31, 2023;

WHEREAS, Section 8.2 (h) of the Management Agreement outlines SNGREC shall provide support resolutions and/or enter into support agreements to confirm they are satisfied with the Duty to Consult;

NOW THEREFORE:

SNGREC approves the Chief of Six Nations of the Grand River Elected Council to execute any and all final form support resolutions, agreements and treaty attestations required by SNGRDC to participate in the Hedley Battery Energy Storage System, subject to the following criteria:
