**RE: Notice of Community Investment of Oxford Battery Energy Storage System (the “Project”)**

In an effort to remain transparent with the Haudenosaunee Confederacy Chiefs Council (HCCC), I am writing to inform you of an upcoming community comment period for the proposed Oxford Battery Energy Storage Project (the “Project”) scheduled for September 16<sup>th</sup> to October 25<sup>th</sup>, 2024.

The purpose of the comment period is to maintain transparency and accountability to the Six Nations of the Grand River Community regarding Six Nations of the Grand River Development Corporation’s (SNGRDC) investments. Now that the Project has obtained a contract from the Independent Electricity Systems Operator (IESO), we’re at a stage where we’d like the Six Nations Community to learn more about the Project and the benefits it brings to the community. The Oxford Project will help the IESO grid by storing power during off-peak times, when there’s high intermittent renewable generation, and supplying electricity during peak times, when demand is high.

The Oxford Project is projected to reduce 1.5 million tonnes of carbon emissions over the 20-year contract period, equivalent to approximately reducing greenhouse gases from 350,000 gasoline-powered passenger vehicles driven for one year. A project of this size (125 MW) can assist in providing electricity for approximately 19,000 homes each year.

SNGRDC’s focus lies in promoting community development and investing in renewable energy, paving the way for a sustainable future for upcoming generations.

SNGRDC and our partner Boralex Inc. would like to invite the HCCC and its members to the community information sessions being held on October 5<sup>th</sup> from 10:00am - 12:00pm and October 10<sup>th</sup> from 5:00pm – 7:00pm at the SNGRDC Boardroom located at 2498 Chiefswood Road. Should HCCC wish to have SNGRDC present at another date during the public comment period, we would be happy to accommodate that request.

SNGRDC and our partner Boralex Inc., are inviting the Six Nations Community to participate in an Investment Review of the Oxford Battery Energy Storage Project (Oxford Project), a **125 MW energy storage facility** has been designed to efficiently store and seamlessly inject energy into the grid as required. This project will assist in **dependable power capacity** by capturing and storing energy from the grid during off-peak times and redistributing it back to the grid when energy demand peaks.

### PROJECT INFORMATION

**PROJECT CAPACITY:** 125 MW

**OWNERSHIP STRUCTURE:**

- 50% SNGRDC; 50% Boralex Inc.

**PROJECT LOCATION:**

- The township of South-West Oxford
- Closest main intersection: Sweaburg Road and Hwy 401
- The project is outside of the Haldimand Tract

**OTHER INFORMATION:**

- The project utilizes aggregate-depleted land. This minimizes environmental impact and repurposes nonarable land, reducing conflicts with agricultural or ecological interests.
- A 125 MW project can assist in providing electricity for approximately 19,000 homes each year
- Boralex has hired Energy Safety Response Group as a consultant to develop an Emergency Safety Response Plan for fire prevention.
- Procuring local: project expects to procure materials and services from local communities (e.g. aggregates, civil, works, machinery).

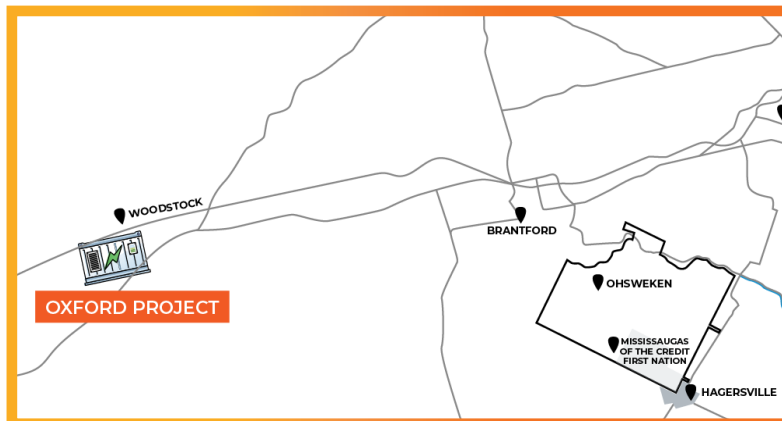
